

## **General contractual conditions**

### *At Peace International Kinesiology Conference 2022*

These General Terms and Conditions (GTC) set out the general terms and conditions governing the contract governing registration for and participation in the At Peace International Kinesiology Conference 2022 (Conference), which is operated by the Hungarian Foundation for Kinesiology (MKA) and is available through the website <https://kinesiologyconference-hungary2021.com/> (Website), and the rights and obligations of persons (Applicants) registering for the Conference.

3. The Organiser reserves the right to change the Conference registration fee, provided that the change will come into effect upon publication on the Website.

4. If, despite all reasonable care on the part of the Organiser, an incorrect price is indicated on the Website, in particular a price that is obviously incorrect, the Organiser is not obliged to offer participation in the Conference at the incorrect price, but may offer participation in the Conference at the correct price, in the knowledge of which the Applicant may withdraw from the purchase.

## **3. How to apply:**

1. The Applicant can register for the Conference by filling in the Registration Form available on the Website. When filling in the Registration Form, the Registrant is required to provide the following information: name of the participant; telephone number of the participant, e-mail address of the participant; company name, billing name; billing address; tax number; details of the conference participation: day ticket or 4-day ticket, participation in the closing party, type of lunch, Terry Webb's training. The Registrant can submit their registration by clicking on the "Register for the Conference" button. By submitting an application, the Applicant accepts all the provisions of these T&Cs and the Privacy Policy available on the Website.

2. The MKA will send a fee request (confirmation) to the e-mail address provided by the Applicant during the application process immediately (automatic message) after receipt of the application and within 72 hours at the latest,

3. In case of payment by bank transfer, the Applicant must pay the Conference fee within the deadline specified in the confirmation e-mail.

#### **4. Payment terms:**

1. The Applicant can pay the participation fee by bank transfer to the bank account of the MKA (for EUR: wise account) indicated in the e-mail confirming the application.

2. The participation fee can be paid on the spot.

#### **5. Rights and obligations of the Parties**

##### *1. Rights and obligations of the Applicant*

1. The Applicant has the right to attend the Conference, to take notes and to use the materials for his/her own purposes.

2. By registering, you acknowledge and agree that you are participating in the Conference in accordance with current health safety and government regulations. The organiser shall not be liable for any resulting damage to the Applicant.

3. No sound, image or video recording of any kind is allowed at the Conference without the written permission of the MKA.

##### *2. Rights and obligations of the Organiser*

1. The Organiser reserves the right to cancel the Conference if the minimum number of participants is not reached or in case of force majeure.

2. Although the Organiser will use its best endeavours to ensure that the Conference is held in accordance with the programme as previously announced, the Organiser reserves the right to change the programme of the Conference without prior notice,
