#### 3. Purpose of data processing

The Data Controller uses the data for the following purpose:

Registration for an event

Recording of registrations, registration of applicants' data, fulfilment of registrations, tasks related to the payment of participation fees, invoicing managing the payment of registration fees, payment of fees and invoicing, contacting Users in relation to the Event.

## 4. Duration of data processing

The Controller shall process personal data for the duration of the purpose of the processing, for the period necessary to achieve the purpose of the processing, in particular for the duration of the legal relationship with the User, or for the period specified in the legislation imposing mandatory processing.

The personal data shall be deleted at the same time as the purpose of the processing ceases to exist or, subject to the conditions laid down in the data protection regulations, without undue delay in the event of the User's request, request for the deletion of his/her data or withdrawal of his/her consent, except for the data that the Data Controller is obliged to keep. The withdrawal of consent shall not affect the lawfulness of processing based on consent prior to its withdrawal.
